2000 FRAUD AND ABUSE

All sub-recipients of Workforce Innovation and Opportunity (WIOA) Title I-B funds, including Pinal County Workforce Development Board (PCWDB), ARIZONA@WORK Pinal County WIOA Title I-B service providers, the ARIZONA@WORK Pinal County One-Stop Operator and contractors must implement policies and procedures to prevent and detect fraud, abuse and criminal activities involving WIOA Title I-B Adult, Dislocated Worker, and Youth program funds.

Additionally, sub-recipients must report allegations, suspicions and complaints of possible fraud, program abuse and criminal activities to the U.S. Department of Labor (DOL) Office of Inspector General (OIG), the Arizona State Attorney General Office, and the Department of Economic Security (DES) Workforce Development Administration (WDA), Office of Finance and Budget, and Pinal County.

2001 STANDARDS OF CONDUCT

Pinal County Workforce Development Board (PCWDB), ARIZONA@WORK Pinal County WIOA Title I-B service providers, the ARIZONA@WORK Pinal County One-Stop Operator and contractors must develop processes to identify violations of terms and conditions. A violation is considered evident when the following General Assurances are not met.

- A. Every reasonable course of action has been taken in order to maintain the integrity of expenditures of public funds and avoid favoritism, questionable activity or improper conduct.

- B. Federal funds have been administered in an impartial manner, free from personal, financial or political gain.
- C. Executive staff and employees avoided situations, which give rise to a suggestion that any decision was influenced by prejudice, bias, special interest or personal gain.

2002 REPORTING REQUIREMENTS

Pinal County Workforce Development Board (PCWDB), ARIZONA@WORK Pinal County WIOA Title I-B service providers, the ARIZONA@WORK Pinal County One-Stop Operator and contractors.

.01 Reportable Issues

Incidents involving possible or suspected fraudulent or criminal use of WIOA Title I-B funds must be reported to the OIG using the DOL’s Incident Report form (OIG 1-156). Reports must also be sent concurrently to the Arizona State Attorney General’s Office and the DES WDA, Office of Finance and Budget, and Pinal County. Incidents requiring reporting include:

A. Allegations of fraud

Fraud is any deceitful act, by omission or willful device, used with the intent to obtain some unjust advantage for one party, or to cause an inconvenience or loss to another party. Types of fraud include embezzlement, forgery, theft, solicitation and receipt of bribes (kickbacks), and falsification of records and claims regarding trainees (e.g., knowingly enrolling ineligible participants).

1. Criminal fraud is a type of larceny and is punishable under both federal and Arizona law as a felony.
2. Civil fraud is subject to tort actions under civil laws.
3. Tort is damage, injury, or a wrongful act done willfully, negligently, or in circumstances involving strict liability, but

not involving breach of contract, for which a civil suit can be brought.

B. Illegal or improper activities

1. An executive or employee of a federally funded agreement or an elected official in Pinal County has solicited or accepted money or any other consideration from a third party for the performance of an act.
2. Reimbursements in whole or in part by the Pinal County Workforce Development Board, ARIZONA@WORK Pinal County, ARIZONA@WORK Pinal County One-Stop Operator or contracts for supplies, materials, equipment or services purchased with sub grant funds are used for any purposes other than for what is allowed by the Federal WIOA.
3. A relative by blood, adoption or marriage of any executive or employee receives favorable treatment for enrollment in services provided by or employment with, the Pinal County Workforce Development Board, ARIZONA@WORK Pinal County service providers, the ARIZONA@WORK Pinal County One-Stop Operator, or contractors. “Relative by blood or marriage” includes: wife, husband, son, daughter, mother, father, brother, brother-in-law, sister, sister-in-law, son-in-law, daughter-in law, mother-in-law, father-in-law, aunt, uncle, niece, nephew, stepparent and stepchild.

C. Misapplication of funds

Misapplication of funds is any use of funds, assets, or property not authorized or provided for in the grant or contract. This category includes, but is not limited to, nepotism, political patronage, use of participants for political activity, intentional services to ineligible enrollees, conflict of interest, failure to report income derived from

federal funds, violation of contract provisions, maintenance of effort violations and the use of the WIOA Title I-B funds for other than WIOA Title I-B purposes.

D. Gross Mismanagement

Gross Mismanagement is an action or situation arising out of management ineptitude or lack of oversight, which leads to a major violation of contract provisions and/or which severely hampers the accomplishment of program goals. These include situations, which lead to waste of government resources and put into serious jeopardy future support for a particular project. This category includes, but is not limited to:

1. Unauditable records;
2. Unsupported costs;
3. Highly inaccurate fiscal and/or program reports;
4. Payroll discrepancies;
5. Payroll deductions not paid to the Internal Revenue Service; and
6. Lack of internal control procedures.

E. Employee/ Participant misconduct

1. Actions occurring during or outside work hours that reflect negatively on the program or its purpose. These may include, but are not limited to:
 - a. Conflict of interest involving outside employment,
 - b. Business and professional activities,
 - c. Receipt of gifts, fees, entertainment and favors,
 - d. Misuse of federal property,

- e. Misuse of official information,
 - f. Forgery or alteration of documents and records;
 - g. Conflicts of interest, kickbacks, or favors to vendors to contractors;
 - h. Misuse of office, position, or authority; and
 - i. Other activities that might adversely affect the confidence of the public regarding the integrity of government funds.
2. A participant displaces a currently employed worker (including partial displacement such as reduction in the hours of non-overtime work, wages or employment benefits). A client is employed or a job opening is filled when:
- a. Any other individual is on layoff from the same or any equivalent job; or
 - b. The employer has terminated the employment of any regular employee or otherwise reduced its workforce with the intention of filling the vacancy created by hiring a participant whose wages are subsidized with WIOA Title I-B funds.
- F. Other suspected criminal activity; and
- G. Situations involving health and safety concerns or loss of funds exceeding \$50,000 are classified as emergencies. In addition to the written incident report, emergencies must be reported immediately to the fraud hotline at 1-800-347-3756.

.02 Assurance Requirements

No action will be taken against any complainant for reasonably disclosing information concerning suspected or actual abuse of the WIOA Title I-B programs. Complainants may choose to remain anonymous and may

send the report directly to DOL OIG or the Office of Financial and Administrative Management (OFAM).

The PCWDB Director, ARIZONA@WORK Pinal County service providers, the ARIZONA@WORK Pinal County One-Stop Operator and contractors must notify employees of the hotline and provide instructions for the [Incident Report](#).

The ARIZONA@WORK Pinal County Director, ARIZONA@WORK Pinal County service providers, the ARIZONA@WORK Pinal County One-Stop Operator and contractors provide policies and procedures to staff, and PCWDB members.

This policy must be prominently displayed in an area where the public and staff can view it.
