

## Leaf Blowers

The following information applies to Area A (North of Arizona Farms Rd and West of Hwy 79)

- ◆ No person will allow a leaf blower to blow material into public roadways at any time.
- ◆ Leaf blowers can only be used on asphaltic concrete, cement concrete, gravel cover, vegetative cover or any combination of the above stabilizers.
- ◆ Leaf blowers will not be used on High Pollution Advisory days except in vacuum mode.



## Restrictions on Vehicle Parking & Use on Vacant Lots

The following information applies to Area A (North of Arizona Farms Rd and West of Hwy 79).

- ◆ All property owners will restrict vehicle parking and usage on an unstabilized vacant lot.
- ◆ Stabilization of the lot must be implemented if the lot is being used.
- ◆ No person can park a motor vehicle on any vacant unstabilized lot without the permission of the owner.
- ◆ The above does not apply to anyone using or parking a vehicle with the permission of the owner.

## Stabilization For Residential Parking and Drives

The following applies to the Pinal County portion of the serious PM10 Nonattainment Area which can also be described as Township 1 North, Range 8 East, Gila & Salt River Base & Meridian.

In this area, the owner and/or operator of any residential property must install and maintain paving or stabilize all affected surfaces.

A stabilization method will consist of one of the following:

- ◆ Paving with asphaltic concrete
- ◆ Paving with Portland cement based concrete
- ◆ Surfacing with a penetrating asphalt and a gravel surface (chip sealing)
- ◆ Surface with and maintaining a 2-inch deep layer of rock
- ◆ Surfacing with a 2-inch deep layer of recycled asphalt
- ◆ Watering with sufficient frequency so as to maintain a crust
- ◆ Surfacing with any other surface treatment (approved by PCAQCD)

Affected areas of a residential property:

- ◆ Areas in excess of 3,000 sq ft used on a regular basis for parking, maneuvering or entrance and outlet of on/off road vehicles.

## Prevention is the Key

- ◆ Prevent vehicles driving on vacant lots by erecting signs, fences, or embankment.



- ◆ Prevent vehicles from parking on unpaved dirt shoulders and street corners. (vehicles for sale)



- ◆ If ground surface has been disturbed, lot owners can re-stabilize the surface by landscaping, vegetation, water, or other treatment approved by PCAQCD.

## Commercial Parking, Drives and Yards

The following applies to Township 1 North Range 8 East.

At any unpaved commercial parking lot, the owner and/or operator will:

- ◆ Restrict vehicle access to only the areas that control measures have been implemented.
- ◆ Dustproof the unpaved commercial parking lot with one of the following:

- a. Paving
- b. Gravel surfacing
- c. Dust suppressants

## Trackout Cleanup Requirement

If trackout occurs:

- a. Clean up immediately from paved areas accessible to the public (sidewalks, curbs, gutters).
- b. Clean up all visible trackout from paved areas at the end of the day.
